

Overview

Worldwide people spend \$100.000.000.000 a year for state lotteries which take 30%-70% fees. That makes lotteries a big loss for participants. It should not be this way. People should be able to participate in a fair lottery with a minimum of costs that only account for the costs of the service itself, not for expenses that are in no way related to the lottery. Hence, we want to make lotteries almost a zero-sum game only charging 2%. 1% is used for running the lottery company and financing its business, 1% is used to constantly buy back our token from the market. Moreover, we want to make the drawings a big show. Stop those boring state lottery drawings! We want to have a show that makes lottery drawings as exciting as watching great movies. The weekly shows will be shown in a live stream on our website and come without any cost.

How the lottery works

From Monday to Saturday people can make their bets via an online website. They will need to connect their wallet for payment, and they are requested to choose an amount they want to bet as the numbers they are betting on. The game is 6|49 so people choose 6 numbers out of 49 available numbers (without repetition). People can bet on their lucky numbers, certain dates or pick the numbers randomly. Moreover, they can make several bets on different combinations of numbers. The amount for betting is up to the participants. This is a huge advantage compared to current lotteries who only accept fixed amounts. These fixed amounts are problematic when aiming to connect different players all over the world and in all different financial situations. Hence, in addition to the low fees, we have another big advantage over current real-life lotteries. Blockchain technology makes it also possible to reduce transaction costs to a very low level and raise transparency to a degree where no current real-life lottery can compete.

How the presale works

In the beginning there will be a lot of costs. A well-built website is to be set up, the legal structure of the company, and much marketing to reach millions and billions of people from different countries. This will initially be financed by the money raised during the presale. Our token enables us to raise this money via a traditional ICO.

Presale investors profit from a low token price. After the end of our presale our burning mechanism guarantees that with every lottery fee raised there will be more and more of our tokens being burnt. Participants of the lottery service pay our 2% service fee in WTW token. 1% is burnt to create upside price pressure. The other 1% finances the lottery business on an ongoing

basis. Of course, presale investors can also use their token to participate in the weekly lotteries since our token is a utility token.

Roadmap

During the presale we will have four price levels going from \$0.2 to \$0.4. Each level will have a token supply of 4m. After the end of presale, we will have four big milestones:

- 1) Programming the lottery website. Rolling out Marketing. Launching our Token on decentralized exchanges.

- 2) Attracting 100.000 weekly lottery players and weekly prize pools of \$1.000.000. Listing our token on centralized exchanges. Increasing the token price to \$1.
- 3) Attracting 1.000.000 weekly lottery players and weekly prize pools of \$10.000.000. Increasing the token price to \$5.
- 4) Attracting 5.000.000 weekly lottery players and weekly prize pools of \$50.000.000. Increasing the token price to \$25.
